History of Karnataka Regional Branch - 1957-2010

The year 2007-08, was a historic and a momentous year in the history of the Karnataka Regional Branch of the Indian Institute of Public Administration. In that year, Karnataka Regional Branch celebrated its Golden Jubilee. Four years have passed since then and it is only befitting that a stock taking is done of the 54 years that have gone by and a record is



kept of the activities year wise ever since the establishment of the Branch in 1957. The need for keeping a record of these activities is all the more relevant since many institutions grow and prosper and celebrate their Golden Jubilee and Centenary years. There are many others who do not grow and prosper and fade away even before the completion of their Golden Jubilee. Institutions which are nurtured well from their infancy and have dedicated and committed people to look after their affairs do flourish.

Karnataka Regional Branch is now recognized as one of the leading and reputed Regional Branches of the country. This is due to the fact that over the past five decades, office bearers, members of the Executive Committee and members of the Branch have consistently taken active interest in organizing programmes and activities year after year especially since 1990. Further, the Government of Karnataka in the Department of Personnel and Administrative Reforms have always been supportive of the activities of the Branch ever since the formation of the Branch in 1957.

Formation of the Branch in 1957:

Three years after the establishment of the IIPA, New Delhi in 1954, a Local Branch of the IIPA was formed in Bangalore in April 1957 and it was converted into a Regional Branch in July 1957. On 13th April 1957, the then first Chief Minister of the then State of Mysore, Sri. S. Nijalingappa inaugurated the Local Branch. The first Chairman of the Local and Regional Branch was the then Chief Secretary of the Mysore State, Sri. P. V. R. Rao, ICS.

Till 1990, the Chief Secretaries of the Government of Karnataka were Chairmen of the Branch in their ex-officio capacity. Many distinguished IAS Officers, academics, scientists / technocrats – some of whom were and are members of the IIPA – have served as Chairmen, Secretaries', Office Bearers and Members of the Executive Committee of the Regional Branch and some of them are happily here with us today. In particular, may be mode of the services rendered to the Branch by late Sri. T. R. Satish Chandran, IAS (Retd.), who served as Chairman of the Karnataka Regional Branch from 1984-85 to 1986-87. The present Chairman Sri. S. Ramanathan had also served as Secretary of the Mysore Regional Branch from 1962-64 and had then edited a book on the "Organization of the Government of Mysore".

Adoption of New Model Bye Laws in 1990:

In 1990, the IIPA, New Delhi, approved the Model Bye Laws of the Regional Branches in the light of the experience gained from the functioning of the Branches. In accordance with this decision, the Model Bye Laws of the IIPA, KRB were adopted in the Special General Body Meeting held in February 1990 and the first Office Bearers and Members of the Executive Committee were elected under the new Bye Laws in the Special AGM held on 12th September 1990.

Since 1990, Sri. S. Ramanathan has been elected as Chairman of the Branch in the biennial elections for ten consecutive terms, totaling 20 years.

In 1990, the Branch had meagre financial resources and was without any accommodation, library, computers and staff. From this humble beginning, the Karnataka Regional Branch with the financial support from the Government of Karnataka has grown to be one of the most active Regional Branches in the country. It has been organizing every year workshops, conferences, seminars and lectures on contemporary issues of public administration with special reference to the policies and programmes of the Government of Karnataka. It has also brought out several important publications. It has a library, computers and full time staff.

Book on 'Landmarks in Karnataka Administration':

To commemorate the Golden Jubilee of the IIPA, New Delhi, the Branch published a book titled 'Landmarks in Karnataka Administration' which was released on 17th October 1998 in Raj Bhavan, Bangalore by the former Governor of Karnataka Sri. Khurshid Alam Khan. The book carries a foreword from the former Chief Minister of Karnataka, late Sri. J. H. Patel. The book contains articles contributed by 28 eminent authors on various areas of socio economic administration in Karnataka. They have attempted to spotlight the evolutionary trends in the selected areas of Karnataka administration since independence / reorganization of the State resulting from the legislative enactments and programmes formulated during the several Five Year Plans. In addition, they have made a broad review of changing policies and programmes over the decades and offered suggestions for improvements in policy formulation and programme implementation.

Golden Jubilee Year - 2007:

To commemorate the Jubilee the Branch organized in collaboration with Government Departments, academic institutions, voluntary organizations and NGO's, lectures by eminent dignitaries and conferences / seminars / workshops on contemporary and important topics of public administration with special reference to the plans, policies and programmes of the Government of Karnataka. The first Golden Jubilee commemoration lecture on 'Role of Lokayukta in Good Governance' was delivered on 2nd June 2007 by Justice Sri. N. Santosh Hedge, Karnataka Lokayukta. Sri. T. N. Chaturvedi, Governor of Karnataka presided over the function.

Karnataka Rajyotsava Award to Chairman, IIPA, KRB - 1998 :

In November 1998, the Chairman of the Branch Sri. S. Ramanathan was conferred the prestigious Karnataka Rajyotsava Award by the Government of Karnataka in recognition of the distinguished services rendered by him in diverse fields of public administration.

A special mention may be made of the Refresher Training Courses organized and being organized by our Branch for Karnataka Government officers in Bangalore and in Asia Plateau, Panchgani, Maharashtra. So far 13 Courses have been organized and these have been funded by the DPAR (AR), GOK. The Course recently organized in Panchgani on the theme of 'Leadership, Ethics and Governance'

Allotment of rent free accommodation for the Branch office :

For several years the Branch has been requesting the Chief Secretary, Government of Karnataka for the allotment of rent free accommodation in a Government building in the vicinity of Vidhana Soudha for housing the Branch office. However, the Government could not take a positive decision due to non availability of accommodation even for housing the offices of the various Government Secretariat Departments. With the construction and commissioning of the new Vikasa Soudha the position eased a bit and the Branch took up again the matter with the Chief Secretary for allotment of rent free accommodation for the Branch.

In June 2007 the then Chief Secretary of the State Sri. P. B. Mahishi was convinced of the need for allotment of rent free accommodation to our Branch and with the approval of the then Chief Minister spacious accommodation measuring nearly 1,000 sq.ft. was allotted in Room No.4 & 5 on Ground Floor in the M. S. Building, 5th Phase. The Branch occupied the premises on 1st September 2007. With the availability of this spacious accommodation, the Branch has been able to extend its activities and also function more effectively.

Our Branch wishes to place on record our special thanks to the then Chief Secretary, Sri. P. B. Mahaishi and Secretary, DPAR Sri. Syed Zameer Pasha and the officers in the department for their help.

An attempt has been made to collect information about the activities of our Branch year-wise from 1957 onwards from the Annual Reports of the IIPA. It was seen that in some years information is not available either about the Office Bearers or about the activities of the Branch.
