#### **Preface**

It gives me great pleasure to place before our esteemed readers the Annual Reports of this Branch from 2011-12 to the present, in one comprehensive volume. It documents the work being done by the Branch in the fulfilment of its aims and objectives. But before doing so, a brief account of its history, evolution and highlights would be in order.

Three years after the establishment of the IIPA, New Delhi in 1954, the Mysore Local Branch of the IIPA was formed in Bangalore in April 1957. It was inaugurated by the Chief Minister of the then State of Mysore, Sri. S. Nijalingappa. It was converted into a Regional Branch in July 1957. The first Chairman of the Branch was the then Chief Secretary of Mysore State, Sri. P.V.R. Rao, ICS. Till 1990, the Chief Secretaries of the Government of Karnataka were Chairpersons of the Branch in an ex-officio capacity. Particular mention may be made of the services rendered by late Sri. T. R. Satish Chandran, IAS (Retd.), who served as Chairman of the Branch from 1984 to 1987.

In June 2007, the then Chief Secretary of the State Sri. P. B. Mahishi, sanctioned rent-free accommodation to the Branch measuring nearly 1,000 sq. ft. in M. S. Building, Bangalore. Since then, the Branch has been able to extend its activities and function more effectively.

To commemorate the Golden Jubilee of our Branch in 2007 a publication titled '**History of Karnataka Regional Branch 1957-2011**' was released by Shri. T. N. Chaturvedi, former Governor of Karnataka and Chairman, IIPA, New Delhi in the presence of His Excellency, the Governor of Karnataka Shri. H. R. Bharadwaj and Justice Shri. N. Santosh Hegde, former Karnataka Lokayukta, at a function held on 17<sup>th</sup> December 2011.

The Branch regularly organizes seminars, webinars, conferences, panel and book discussions, training programmes and workshops in the areas of administration, governance and public policy. It has signed **Memoranda of Understanding** with leading institutions in Bengaluru which include Jain University, the Institute for Social and Economic Change, University Law College of Bangalore University, BMS College of Law, Ramaiah Public Policy Centre, Bengaluru, and Karnataka State Rural Development and Panchayat Raj University, Gadag. It would be useful to recall the objectives and modes of collaboration, as visualized in the Memoranda of Understanding.

#### **Objectives and Modes of Collaboration**

The goal of the Memoranda of Understanding is to foster collaboration, and provide opportunity for professional, scholarly and academic interaction in matters relating to Public Policy, Governance, Administration and related areas, and to facilitate advancement of knowledge in these areas, based on reciprocity

and mutual benefit. The signatories of the MoU agree to explore the possibility of engaging in the following modes of collaboration:

- 1. Holding collaborative programmes in the form of lectures, seminars, workshops, panel discussions, symposia, webinars, training programmes and the like in Public Policy, Governance, Administration and related areas.
- 2. Extending cooperation to each other in the areas of teaching, research, publication and other activities associated with Public Policy, Governance, Administration and related areas;
- 3. Preparation of Background Papers, Compendiums, White Papers, Dossiers, Policy Documents and the like on topical issues related to Public Policy, Governance, Administration and related areas, to be submitted to the Government of Karnataka, which could be of assistance to it, in policy formulation in those areas.
- 4. Publication of Proceedings of jointly-organized Seminars, Conferences, Workshops, Webinars, etc., as well as Background Papers, Compendiums, White Papers, Dossiers, Policy Documents and the like, on topical issues related to Public Policy, Governance, Administration and related areas.
- 5. Mutual sharing of infrastructure, resources and expertise in the organization of programmes and activities described above.

The Branch is bringing out monthly virtual newsletters called, 'Vidyunmana Suddipatra' regularly since August 2020. Printed compendiums of these newsletters are being published annually.

Apart from these, the Branch has nearly 30 other publications to its credit.

The award for "**Best Performing Branch**" was conferred on the Karnataka Regional Branch by the IIPA, New Delhi at the Annual General Meeting in New Delhi in October 2022.
